- To confirm and sign the minutes of the meeting held on the 6th May 2025 / I gadarnhau ac arwyddo cofnodion y cyfarfod a gynhaliwyd ar 6ed Mai 2025
- Matters / correspondence arising / Materion / gohebiaeth yn codi:
 - a. Issue with motorbike(s) – Increase in reports from local residents about motorbike(s) being ridden at speed towards the Common, and riders not wearing helmets. Has been reported previously but issue is still ongoing along with increase in complaints / Problem gyda beic(iau) modur – Cynnydd mewn adroddiadau gan drigolion lleol am feic(iau) modur yn cael eu reidio ar gyflymder tuag at y Comin, a beicwyr ddim yn gwisgo helmedau. Adroddwyd yn flaenorol ond mae'r mater yn dal i fynd rhagddo ynghyd â'r cynnydd mewn cwynion.
 - b. Wales Air Ambulance – Thankyou letter received for donation of £500 given on 19th March 2025 / Ambiwlans Awyr Cymru – Derbyniwyd llythyr diolch am rodd o £500 a roddwyd ar 19 Mawrth 2025.
 - c. FILCA Course – SLCC approved the bursary application, for a 50% deduction off the cost of the FILCA (Financial Introduction to Local Council Administration Course). Clerk has completed, passed and received certificate, which has been placed onto the Council website as required / Cwrs FILCA – Cymeradwyodd SLCC y cais am fwrsariaeth, am 50% o ddidyniad oddi ar gost yr FILCA (Cwrs Cyflwyniad Ariannol i Weinyddu Cyngorau Lleol). Clerc wedi cwblhau, pasio a derbyn tystysgrif, sydd wedi ei gosod ar wefan y Cyngor yn ôl yr angen.
 - d. NALC Pay Awards 2025-2026 – Clerk received information that a 'full and final' offer of 3.2% increase on each scalepoint has been issued to NALC, and will be awarded on the basis that it will not be lower than this. It is hoped that this will be awarded by end May, backdated to 1st April so that it can be included in May payrun. Clerk waiting for further updates / Dyfarniadau Cyflog NALC 2025-2026 – Derbyniodd y Clerc wybodaeth bod

cynnig 'llawn a therfynol' o gynnydd o 3.2% ar bob pwynt graddfa wedi'i roi i NALC, ac y caiff ei ddyfarnu ar y sail na fydd yn is na hyn. Y gobaith yw y bydd hwn yn cael ei ddyfarnu erbyn diwedd mis Mai, wedi'i ôl-ddyddio i 1 Ebrill fel y gellir ei gynnwys yn rhediad cyflog mis Mai. Clerc yn aros am ddiweddariadau pellach.

e. Section 6 Duty Overview (Biodiversity Action Plan) – all C&TCs are required to complete and publish their Section 6 reports by end of 2025, and producing a new action plan in preparation for the next reporting round. Clerk has produced a “draft” Section 6 Report for approval by Cllrs / Trosolwg o Ddyletswydd Adran 6 (Cynllun Gweithredu Bioamrywiaeth) – mae'n ofynnol i bob C&TC gwblhau a chyhoeddi eu hadroddiadau Adran 6 erbyn diwedd 2025, a chynhyrchu cynllun gweithredu newydd i baratoi ar gyfer y cylch adrodd nesaf. Clerc wedi cynhyrchu Adroddiad Adran 6 “drafft” i'w gymeradwyo gan y Cyng.

f. Clerk has sent via Objective connect (Audit Wales secure site for Accounts) all required paperwork for our Basic Audit. Cllrs to approve the Audit Notice which will be published on the website as from 8th June 2025 (emailed with agenda). Awaiting audited accounts from Accountant which are required by end August (or sooner) / Clerc wedi anfon yr holl waith papur gofynnol ar gyfer ein Harchwiliad Sylfaenol drwy Amcan connect (safle diogel Archwilio Cymru ar gyfer Cyfrifon).
