- Llangadog RFC / Clwb Rygbi Llangadog –

 - Lawn Cemetery / Mynwen Lawnt:- Site meeting held on Tuesday 19th May 2026. Darren Mills, Cllr Dafydd Morgan, Cllr Wyn Jones and Clerk attended. Discussions on how to proceed with extending lawn cemetery and any other works discussed. Waiting for plans from Darren Mills to discuss and approve / Cynhaliwyd cyfarfod safle ddydd Mawrth 19eg Mai 2026.  - Llangadog Playground / Maes Chwarae Llangadog – Clerk has been in contact with Sutcliffe Play for quotes on the maintenance of playground areas and equipment. Clerk requested a quote from Mens Sheds for 1 x picnic bench and 1 x bench (made from heavy duty wood) to replace current seating. Quote received 1 x 6ft picnic bench £250 and 1 x bench £200 (both made from solid wood.  - Village Green / Lawnt y pentre – Clerk ordered 3 x A3 “No Dogs Allowed” signs to be placed around Village Green, (2 x normal, 1 x fluorescent). Cllr Wyn Jones has taken one sign to install. Cllr Aaron Hughes to install other two signs where appropriate.
