S.137 Payments – Clerk checked the Powers and Duties of Local Councils for a number of functions and the regulations under which statutory provisions are made and financial assistance can be given. S.137 should only be used when / Taliadau Adran 137 – Gwriodd y Clerc Bwerau a Dyletswyddau Cynghorau Lleol ar gyfer nifer o swyddogaethau a'r rheoliadau y gwneir darpariaethau statudol a gellir rhoi cymorth ariannol oddi tanynt. ***Section 137 (S.137) of the Local Government Act 1972 is a legal provision in the UK empowering local councils (parish, town, and community councils) to spend a limited amount of money on community projects for which they have no other specific statutory power. It acts as a "power of last resort" for direct community benefit.***

b. Vacancy for an Additional Community Governor (Llangadog School) -
