5446/24 – Auditor Generals report and audit opinion – Clerk informed Cllrs that the audit had been completed and signed off by Audit Wales. 5449/24 – United Pet Foods – issue raised by resident(s) in regards to the site entrance (by the railway car park) is sometimes still being used for HGV's to enter / leave the factory. In the event that railway users or Network Rail vehicles are parked in the car park, large vehicles cannot drive through safely. Cllrs discussed further and it was agreed that this issue will continue to be monitored / United Pet Foods – mae mater a godwyd gan breswlydd/preswylwyr ynghylch mynedfa'r safle (ger maes parcio'r rheilffordd) weithiau'n dal i gael ei ddefnyddio er mwyn i HGV's ddod i mewn / gadael y ffatri.
