5422/24 – Apologies from Cllr Haulwen Booth and Cllr Hugh Davies / Ymddiheuriadau gan y Cyng Haulwen Booth a'r Cyng Hugh Davies

5423/24 – Declaration of Interest – No Declaration of Interests / dim datganiadau o ddiddordeb.

5424/24 – Previous meeting minutes dated 1st October 2024 approved by Cllr Wyn Jones and Cllr Jennifer Hughes / Cymeradwywyd cofnodion y cyfarfod blaenorol dyddiedig 1 Hydref 2024 gan y Cyng. Wyn Jones a'r Cynghorydd Jennifer Hughes

5425/24 – To receive Councillors reports on events and meetings attended on behalf of the Council – Cllr Dafydd Morgan attended the School Governors Meeting and it was discussed about a gate entrance in between the school and the Rugby Club. Cllrs agreed that this would not be an issue / I dderbyn adroddiadau'r Cynghorwyr ar ddigwyddiadau a chyfarfodydd a fynychwyd ar ran y Cyngor – mynychodd y Cyng Dafydd Morgan y Cyfarfod Llywodraethwyr Ysgol a thrafodwyd mynedfa giât rhwng yr ysgol a'r Clwb Rygbi. Cytunodd y Cynghorwyr na fyddai hyn yn broblem.

5426/24 – Pay Agreement 2024/2025 – Clerk informed that new pay agreement has been agreed for Clerk/RFOs. As pay award was granted in January 2024, Cllrs to discuss further in January 2025 / Cytundeb Tâl 2024/2025 – Hysbysodd y Clerc fod cytundeb tâl newydd wedi ei gytuno ar gyfer Clerc/CGR. Gan fod codiad cyflog wedi'i ganiatáu ym mis Ionawr 2024, bydd y Cynghorwyr yn trafod ymhellach ym mis Ionawr 2025.

5427/24 – Model Financial Standing Orders (April 2024). Clerk informed that new standing orders had been updated and that specific areas may require adaption to suit our Councils needs. Clerk to update if required and get approved at meeting in December / Rheolau Sefydlog Ariannol Enghreifftiol (Ebrill 2024). Dywedodd y Clerc fod y rheolau sefydlog newydd wedi eu diweddarau ac efallai y bydd angen addasu meysydd penodol i weddu i anghenion ein Cyngor. Clerc i ddiweddarau os oes angen a chael ei gymeradwyo yn y cyfarfod ym mis Rhagfyr.

5428/24 – Clerk informed Cllrs of 'HeloBlod' which is a Welsh Government website that can be used for Welsh Translation. They can translate up to 500 words in to Welsh at no cost,

which starts at the 1st of every month / Hysbysodd y Clerc y Cyngorwyr am 'HeloBlod' sef gwefan Llywodraeth Cymru y gellir ei defnyddio ar gyfer Cyfieithu Cymraeg. Gallant gyfieithu hyd at 500 o eiriau i'r Gymraeg am ddim, sy'n dechrau ar y 1af o bob mis.

5429/24 – Terms of Reference for Council meetings – New document received from One Voice Wales. Clerk to check and update our Terms of Reference if required and get approved at meeting in December / Cylch Gorchwyl cyfarfodydd y Cyngor – Derbyniwyd dogfen newydd gan Un Llais Cymru. Clerc i wirio a diweddarau ein Cylch Gorchwyl os oes angen a chael ei gymeradwyo yn y cyfarfod ym mis Rhagfyr.

5430/24 – Donation (Maintenance Gwynfe Cemetery – Cllr Hugh Davies requested on behalf of a resident, if a donation could be made to the maintenance of Gwynfe Cemetery. Clerk informed that as the cemetery is not owned by LCC, we have no obligation to donate. It was agreed, that no donation can be made, as LCC do not donate towards maintenance of other cemeteries within the Ward / Rhodd (Cynnal a Chadw Mynwent Gwynfe - Gofynnodd y Cyng Hugh Davies ar ran preswlydd, os gellir gwneud cyfraniad i gynnal a chadw Mynwent Gwynfe. Clerc wedi hysbysu gan nad yw'r fynwent yn eiddo i CCLI, nid oes rheidrwydd arnom i gyfrannu. Cytunwyd, na ellir rhoi rhodd, gan nad yw CCLI yn cyfrannu tuag at gynnal a chadw mynwentydd eraill o fewn y Ward.

5431/25 – Section 137 Expenditure Limit for 2025-2026 – Letter received notifying that the appropriate sum for the purposes of Section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for Community and Town Councils in Wales for the financial year 2025-2026 is £11.10 / Adran 137 Terfyn Gwariant ar gyfer 2025-2026 – Derbyniwyd llythyr yn hysbysu bod y swm priodol at ddibenion Adran 137(4)(a) o Ddeddf Llywodraeth Leol 1972 (Deddf 1972) ar gyfer Cyngorau Cymuned a Thref yng Nghymru am y flwyddyn ariannol 2025-2026 yw £11.10.

5431/24 – Speeding Issue (Ysgol Llangadog) – County Cllr Andrew Davies informed that there is an ongoing issue of speeding by Ysgol Llangadog. Cllrs agreed that there is an urgent need for a speed camera. There is currently "sleeping policeman" by the school but this does not deter drivers speeding, more so, motorbikes, as they ride through the gap. An original "sleeping policeman" was removed from the road prior to a large bike race being held and was never replaced. A request has also been made to Linda Davies-Evans (Council Development) in relation to part of the land that is currently being held for affordable housing, to be used for playground facilities. Cllrs agreed that County Cllr Andrew Davies move forward with this issue / – Mater Goryrru (Ysgol Llangadog) – Dywedodd y Cyngorwyr Sir Andrew Davies, bod yna broblemau parhaus o oryrru wrth ymyl Ysgol Llangadog. Cytunodd y Cyngorwyr fod angen dybryd am gamera cyflymder. Ar hyn o bryd mae "heddwys cysgu" wrth ymyl yr ysgol ond nid yw hyn yn atal gyrwyr rhag goryrru, yn fwy felly, beiciau modur, wrth iddynt reidio trwy'r bwlch. Cafodd "heddwys cysgu" gwreiddiol ei dynnu oddi ar y ffordd cyn cynnal ras feiciau fawr ac ni chafodd ei ddisodli. Mae cais hefyd wedi'i wneud i Linda Davies-Evans (Datblygu'r Cyngor) mewn perthynas â rhan o'r tir sy'n cael ei gadw ar hyn o bryd ar gyfer tai fforddiadwy, i'w ddefnyddio ar gyfer cyfleusterau maes chwarae. Cytunodd y Cyngorwyr fod y Cyngorwyr Sir Andrew Davies yn symud ymlaen gyda'r mater hwn.

5432/24 – Donation Request – Radio Glangwilli and Wales Air Ambulance. Cllrs agreed to discuss further in the Finance meeting to be held in March 2025 / Cais am gyfraniad –

Radio Glangwilli ac Ambiwylans Awyr Cymru. Cytunodd y Cynghorwyr i drafod ymhellach yn y cyfarfod Cyllid i'w gynnal ym mis Mawrth 2025.

5433/24 – Current Ongoing Issues / Materion Parhaus Cyfredol

- a. Footpath / Vicarage Road & Walters Road. Cllr Dafydd Morgan informed that a “People Counter Sensor” has been placed at the entrance to the footpath and it would be in place for a year. No further work will be completed on the footpath at this stage. Await updates in 2025
- a. Llwybr Troed / Vicarage Road a Heol Gwallter. Dywedodd y Cyng Dafydd Morgan fod “Synhwyrdd Cownter Pobl” wedi ei osod wrth y fynedfa i'r llwybr troed ac y byddai yn ei le am flwyddyn. Ni fydd unrhyw waith pellach yn cael ei gwblhau ar y llwybr troed ar hyn o bryd. Aros am ddiweddariadau yn 2025.
- b. Faulty Street Light (Ivorite Cottage) – Cllr Wyn Jones met with Arwel Price to discuss options for replacing faulty street light, as majority of companies will not supply just one solar light. Cllr Wyn Jones awaiting update from Arwel Price / Golau Stryd Diffygiol (Ivorite Cottage) – Cyfarfu'r Cyng Wyn Jones ag Arwel Price i drafod opsiynau ar gyfer newid golau stryd diffygiol, gan na fydd y mwyafrif o gwmnïau'n cyflenwi dim ond un golau solar. Cyng Wyn Jones yn disgwyl diweddariad gan Arwel Price.
- c. Red Lion Definitive Map – No further updates / c. Map Diffiniol Red Lion – Dim diweddariadau pellach.
- d. Carreg Sawdde Bus stop – CCC has completed their one year inspection and clean of the bus shelter and the potholes have now been filled.
- d. Arosfa bws Carreg Sawdde – Mae CSC wedi cwblhau eu harchwiliad blynyddol ac wedi glanhau'r lloches bws ac mae'r tyllau wedi eu llenwi.
