Agenda Items

5352/24 – Apologies from Cllr Hugh Davies. Peter Rees also sent apologies (Llandovery RFC) and meeting to be re-scheduled for the next meeting in June. Ymddiheuriadau gan y Cyng Hugh Davies. Anfonodd Peter Rees ymddiheuriadau hefyd (Clwb Rygbi Llanymddyfri) y cyfarfod i'w ail-drefnu ar gyfer cyfarfod mis Mehefin.

5353/24 – Declaration of Interest – No declaration of interests / Datgan Diddordeb – Dim datganiad o ddiddordeb.

5354/24 – Previous meeting minutes dated 2nd April 2024 approved by Cllr Aaron Hughes and seconded by Cllr Jennifer Hughes / Cymeradwywyd cofnodion y cyfarfod blaenorol dyddiedig 2 Ebrill 2024 gan y Cyng Aaron Hughes ac eiliwyd gan y Cyng Jennifer Hughes.

5356/24 – To receive Councillors reports on events and meetings attended on behalf of the Council – no meetings or events attended / Derbyn adroddiadau Cyngorwyr ar ddigwyddiadau a chyfarfodydd a fynychwyd ar ran y Cyngor – ni fynychwyd unrhyw gyfarfod na digwyddiadau.

5357/24 – Llangadog Playground – Cllrs discussed further issues raised by local residents about the current facilities at the playground and the possibility of asking CCC for a portion of the proposed building land adjacent to the playground. Clerk informed that a letter had already been sent to CCC in September 2023, and the request was denied. Cllr Dafydd Morgan informed Cllrs that Llandeilo had recently opened a “Pump Track” for children to use and that maybe Llangadog could also have one based on an area of the Village Green. Clerk to gain further information on what company completed this for Llandeilo and how it was funded / Cae Chwarae Llangadog – Bu'r Cyngorwyr yn trafod materion pellach a godwyd gan drigolion lleol ynghylch y cyfleusterau presennol yn y maes chwarae a'r posibilrwydd o ofyn i CSC am ran o'r tir adeiladu arfaethedig ger y maes chwarae. Hysbysodd y Clerc bod llythyr eisoes wedi ei anfon i CSC ym mis Medi 2023, ond gwrthodwyd y cais. Dywedodd y Cyng Dafydd Morgan wrth y Cyngorwyr fod Llandeilo wedi agor “Trac Pwmp” yn ddiweddar fel y gall y plant wneud ddefnydd ohono, ac efallai y byddau

modd i Llangadog gael un ai godi ar ardal o Lawnt y Pentref. Clerc i gael rhagor o wybodaeth am ba gwmni a gwblhaodd y gwaith yn Llandeilo a sut y cafodd ei ariannu.

5358/24 – 20 mph speed limit (Ysgol Llangadog) – County Cllr Andrew Davies reported that local residents had complained about drivers not adhering to the 20mph speed limit on entering the village by the school and local housing area. Clerk had previously reported this to CCC, and has reported this issue again to Mike Jacob (CCC) and also GoSafe. A reply was sent back from GoSafe on 2nd May, who will complete an assessment of the location as they continue to consider new enforcement locations following collisions or high risk concerns, in a 20 mph area. Clerk to follow this up / Terfyn cyflymder 20 mya (Ysgol Llangadog) – Adroddodd y Cynghorydd Sirol Andrew Davies fod trigolion lleol wedi cwyno am yrwyr ddim yn cadw at y cyfyngiad cyflymder 20 mya wrth ddod i mewn i'r pentref ger yr ysgol a'r ardal dai leol. Clerc wedi adrodd hyn i CSC yn flaenorol, ac wedi adrodd y mater hwn eto i Mike Jacob (CSC) a hefyd 'GanBwyll'. Derbyniwyd ateb yn ôl gan 'GanBwyll' ar 2 Mai. Byddant yn cwblhau asesiad o'r lleoliad wrth iddynt barhau i ystyried lleoliadau gorfodi newydd yn dilyn gwrthdrawiadau neu bryderon risg uchel, mewn ardal 20 mya. Clerc i ddilyn hyn i fyny.

5359/24 – County Cllr Andrew Davies informed that the issue of CCC removing the Public Refuse bin, in Bethlehem, had been reported and that in the interests of community hygiene, can the bin be reinstated. Awaiting response / Dywedodd y Cynghorydd Sir Andrew Davies ei fod wedi codi'r mater o gael gwared a'r bin sbwriel cyhoeddus ym Methlehem gan y CS, ac er budd hylendid cymunedol, y dylid adfer y bin. Aros am ymateb

5360/24 – Annual Independent Playground Review – Cllr Dafydd Morgan and Cllr John Hampson to arrange a site meeting to check if there are any maintenance issues of concern and to compile a report of any findings / Adolygiad Annibynnol Blynnyddol y Maes Chwarae – Cyng Dafydd Morgan a'r Cyng John Hampson i drefnu cyfarfod safle i wirio a oes unrhyw faterion cynnal a chadw sy'n peri pryder ac i lunio adroddiad o unrhyw ganfyddiadau.

Cllr Aaron Hughes and Cllr Jennifer Hughes confirmed they would like to attend. Clerk to inform County Organiser to give their details / C.F.F.I Sir Gar. CCC has discontinued the current consultation following correspondence received and CCC will undertake further preparatory steps in engaging with Governors and staff at both schools in relation to the proposals / Ymgynghoriadau MYA ECS – Ysgol Rhys Pritchard / Ysgol Llangadog. 5364/24 – Current Ongoing Issues / Materion Cyfredol Cyfredol

- a. Footpath / Vicarage Road & Walters Road. Cllr Dafydd Morgan informed that a section of the footpath had been tarmacked, but no further work as previously discussed had been completed. Issue ongoing / a. Llwybr Troed / Vicarage Road a Heol Gwallter. Dywedodd y Cyng Dafydd Morgan fod rhan o'r llwybr troed wedi'i tharmacio, ond nad oedd unrhyw waith pellach fel y trafodwyd yn flaenorol wedi'i gwblhau. Mater yn parhau
- b. Faulty Street Light – Cllrs discussed again, and agreed, that as this issue has not been resolved and that the costs involved for CCC to complete are too high. It was therefore agreed, to investigate costs for installing a solar light. Clerk to follow this up and report at next meeting / b. Golau Stryd Diffygiol - Trafododd y Cynghorwyr eto, a chytunwyd, gan nad yw'r mater hwn wedi'i ddatrys a bod y costau i CSC ei gwblhau yn rhy uchel. - c. Red Lion Definitive Map – no further updates / Map Diffiniol Red Lion – dim diweddariadau pellach.
- d. Carreg Sawdde Bus stop – no further updates. County Cllr Andrew Davies to follow up with CCC / Safle bws Carreg Sawdde – dim diweddariadau pellach. Cyng Sir Andrew Davies i ddilyn i fyny gyda CSC.
- e. Carreg Sawdde Common – No further updates / Comin Carreg Sawdde – Dim diweddariadau pellach
- f. Defib (Llangadog Village) – Cllrs agreed that the old telephone box (outside Goose & Cuckoo) be ideal place to install. Clerk to contact BT to get this decommissioned so that it can be used / Defib (Pentref Llangadog) – Cytunodd y Cynghorwyr fod yr hen flwch ffôn (y tu allan i Goose & Cuckoo) yn lle delfrydol i'w osod. Clerc i gysylltu â BT i ddadgomisiynu hwn fel y gellir ei ddefnyddio.
- g. Woodland Creation Area – Cllrs had no objections to the altered grant type. Clerk to reply / Ardal Creu Coetir - nid oedd gan y Cynghorwyr unrhyw wrthwynebiad i'r newidiadau ar y math o grant. Clerc i ateb.
- h. Donation Request Cylch Meithrin – Email received giving update on queries previously requested by Cllrs in regards to the donation request towards the new tables. Cllrs discussed further and agreed that they are unable to contribute at this time / Cais am gyfraniad Cylch Meithrin – E-bost wedi ei dderbyn yn rhoi diweddariad ar ymholiadau y gofynnwyd amdanynt yn flaenorol gan y Cynghorwyr ynglŷn â'r cais am gyfraniad tuag at y byrddau newydd. Trafododd y Cynghorwyr ymhellach a chytunwyd nad ydynt yn gallu cyfrannu ar hyn o bryd.
