5499/25 – No apologies / Dim ymddiheuriadau

5500/25 – No Disclosures or Declaration of Interests noted / Dim Datgeliadau neu Ddatganiad o Ddiddordeb wedi eu nodi.

5501/25 – Previous meeting minutes dated 4th March 2025 approved by Cllr Dafydd Morgan and seconded by Cllr Alun Hughes / Cymeradwywyd cofnodion y cyfarfod blaenorol dyddiedig 4ydd Mawrth 2025 gan y Cynghorydd Dafydd Morgan ac eiliwyd gan y Cyng Alun Hughes .

5502/25 – Ysgol Llangadog (Entry Gate) – Cllr Dafydd Morgan discussed an entry gate being made available, from Ysgol Llangadog onto the area of the RFC field. Cllrs agreed. Cllr Alan Price to inform Mrs Anita Price, Ysgol Llangadog, so that a quote can be given for Cllrs to approve the payment / Ysgol Llangadog (Giât Mynediad) – Bu'r Cyng. Dafydd Morgan yn trafod y byddai giât mynediad yn fantais o Ysgol Llangadog i ardal cae'r Clwb Rygbi. Cytunodd y Cynghorwyr. Y Cyng Alan Price i hysbysu Mrs Anita Price, Ysgol Llangadog, fel y gellir rhoi dyfynbris i'r Cynghorwyr gymeradwyo'r taliad.

5503/25 – Cllr Dafydd Morgan reported that there has been an issue raised, by a local resident, in regards to parking outside of a private property. Currently the only place for a vehicle to park is outside the property, for safety of the children to catch the school bus (Llangadog). Cllrs discussed further, and although they understand the issues and concerns raised, unfortunately, as a Community Council they are not able to become involved in personal disputes between residents. Cllrs agreed that the resident should contact the Transport Department CCC to report the issue. Clerk to email / Dywedodd y Cyng. yn deall y materion a'r pryderon a godwyd, yn anffodus, fel Cyngor Cymuned nid ydynt i fod yn rhan o anghydfod personol rhwng trigolion. Cytunodd y Cynghorwyr y dylai'r preswilydd gysylltu â'r Adran Drafnidiaeth CSC i adrodd y mater. Clerc i e-bostio.

5504/25 – Llangadog Community Centre – Request letter received for support towards the car park markings being repainted at the Hall car park. Cllrs requested a quote for the cost of this work, and if this was for a donation towards the cost, or full payment. Clerk to email request quote / Canolfan Gymunedol Llangadog – Derbyniwyd llythyr cais am gefnogaeth i ail-baentio'r marciau maes parcio ym maes parcio'r Neuadd. - b. Faulty Street Light (Ivorite Cottage) – Cllr Wyn Jones informed that a site meeting, will hopefully be within the week / Dywedodd y Cyng Wyn Jones ei fod yn gobeithio cael cyfarfod safle o fewn yr wythnos.
- c. Red Lion Definitive Map – No further updates / Dim diweddariadau pellach
- d. Cattle Grid – Nantfforchog, Gwynfe – County Cllr Andrew Davies informed that a new grid has been ordered and currently being fabricated, hopefully to be installed within the next 3-4 weeks. Cllr Alan Price requested that size needs to be at least an extra 2-3 ft, County Cllr Andrew Davies to inform CCC / Grid Gwartheg – Nantfforchog, Gwynfe – Dywedodd y Cyng Sir Andrew Davies fod grid newydd wedi'i archebu ac yn cael ei wneud ar hyn o bryd, a'r gobaith yw y bydd yn cael ei osod o fewn y 3-4 wythnos nesaf.
