5529/25 – Apologies from Cllr Wyn Jones / Ymddiheuriadau gan y Cynghorydd Wyn Jones.

5530/25 – No Disclosures or Declaration of Interests noted / Dim Datgeliadau neu Ddatganiad o Ddiddordeb wedi eu nodi.

5531/25 – Previous meeting minutes dated 6th May 2025 approved by Cllr Alun Evans seconded by Cllr Alan Price / Cofnodion y cyfarfod blaenorol dyddiedig 6ed Mai 2025 wedi'u cymeradwyo gan y Cynghorydd Alun Evans, eiliwyd gan y Cynghorydd Alan Price.

5532/25 – Issue with motorbikes / cars speeding – There have been increased reports and complaints from local residents about the motorbike(s) being ridden at speed towards the Common, and riders not wearing helmets. Cllr Dafydd Morgan informed that the police, after previous warnings, confiscated the motorbike(s). There has also been reports about cars and motorbikes speeding day and night, along the A4069 and using certain areas to meet in groups / Problem gyda beiciau modur / ceir yn goryrru – Mae yna gynnydd mewn adroddiadau a chwynion gan drigolion lleol am y beiciau modur yn cael eu gyrru ar gyflymder tuag at y Comin, a beicwyr nad ydynt yn gwisgo helmedau. Hysbysodd y Cynghorydd Dafydd Morgan fod yr heddlu, ar ôl rhybuddion blaenorol, wedi atafaelu'r beiciau modur. Mae yna hefyd adroddiadau am geir a beiciau modur yn goryrru yn ystod y dydd a'r nos, ar hyd yr A4069 ac yn defnyddio rhai ardaloedd i gyfarfod mewn grwpiau.

5533/25 – Wales Air Ambulance – Clerk informed that a letter of thanks had been received for the donation of £500 / Ambiwylans Awyr Cymru – Hysbysodd y clerc fod llythyr diolch wedi dod i law am y rhodd o £500.

5536/25 – Section 6 Duty (Biodiversity Plan) – Clerk informed that all C&TCs are to publish their Section 6 report by the end of 2025. Clerk to check report and update as required / Dyletswydd Adran 6 (Cynllun Bioamrywiaeth) – Hysbyswyd y Clerc y dylai pob C&TC gyhoeddi eu hadroddiad Adran 6 erbyn diwedd 2025. Y Clerc i wirio'r adroddiad a'i ddiweddarau yn ôl yr angen.

5537/25 – Audit Wales – Clerk informed that all paperwork required for the Basic Audit had been sent to Audit Wales via Objective Connect and that the Audit Notice will be published as from 8th June 2025 on the website. Clerk still waiting for accounts to be audited / Archwilio Cymru – Hysbysodd y Clerc fod yr holl waith papur angenrheidiol ar gyfer yr Archwiliad Sylfaenol wedi'i anfon at Archwilio Cymru drwy Objective Connect ac y bydd yr Hysbysiad Archwilio yn cael ei gyhoeddi ar y wefan o 8 Mehefin 2025 ymlaen. 5538/25 – Current Ongoing Issues / Materion Parhaus Cyfredol

- a. Footpath / Vicarage Road & Walters Road - footpath has finally been completed and a new gate installed. No further action / Mae'r llwybr troed wedi'i gwblhau o'r diwedd a giât newydd wedi'i gosod. Dim camau pellach.
- b. Faulty Street Light (Ivorite Cottage) – Cllr Aaron Hughes to contact Cllr Wyn Jones for update / b. Golau Stryd Diffygiol (Ivorite Cottage) – Y Cynghorydd Aaron Hughes i gysylltu â'r Cynghorydd Wyn Jones i gael y wybodaeth ddiweddaraf.
- c. Red Lion Definitive Map – No further updates / Dim diweddariadau pellach.

- f. Speeding Issues (Ysgol Llangadog) – County Cllr Andrew Davies informed that the cost for Driver Feedback Signs would be £5,750 x 1 or £10,750 x 2 and that Mike Jacobs (CCC) would be happy to consider a share cost. Cllrs

discussed further and it was agreed to ask CCC if they would be willing to pay the cost of one sign and LCC pay for a second. County Cllr Andrew Davies to follow this up with Mike Jacobs / f. Materion Goryrru (Ysgol Llangadog) – Hysbysodd y Cynghorydd Sir Andrew Davies y byddai cost Arwyddion Adborth Gyrwyr yn £5,750 x 1 neu £10,750 x 2 ac y byddai Mike Jacobs (CSC) yn hapus i ystyried rhannu'r gost. Trafododd y Cynghorwyr ymhellach a chytunwyd i ofyn i CSC a fyddent yn fodlon talu cost un arwydd ac i LCC dalu am ail un. Y Cynghorydd Sir Andrew Davies I ddilyn hyn i fyny gyda Mike Jacobs.

- g. Llangadog Community Centre – Cllrs agreed £300 donation towards the cost. Clerk paid the donation and a letter of thanks was received from the Committee. No further action / g. Canolfan Gymunedol Llangadog – Cytunodd y Cynghorwyr ar rodd o £300 tuag at y gost. Talodd y Clerc y rhodd a derbyniwyd llythyr diolch gan y Pwyllgor. Dim camau gweithredu pellach.

It has also been given full approval, therefore, no further objections will be considered / E/40736 – Maes Carafanau a Gwersylla Brynderwen.
