5474/25 – No Disclosures or Declaration of Interests noted / Dim Datgeliadau neu Ddatganiad o Ddiddordeb wedi eu nodi.

5475/25 – Previous meeting minutes dated 7th January 2025 approved by Cllr Haulwen Booth and seconded by Cllr Aaron Hughes / Cymeradwywyd cofnodion y cyfarfod blaenorol dyddiedig 7 Ionawr 2025 gan y Cynghorydd Haulwen Booth ac eiliwyd gan y Cyng Aaron Hughes /

5476/25 – Letter of application received from Mr Alun Evans, to fill the vacancy of Cllr for Llangadog Ward. Mr Evans attended the meeting and was voted in by all Cllrs. Clerk to get Declaration Register updated with his details in March meeting / Llythyr cais wedi ei dderbyn oddi wrth Mr Alun Evans, i lenwi swydd wag y Cynghorydd dros Ward Llangadog. Mynychodd Mr Evans y cyfarfod a phleidleisiwyd i mewn gan yr holl Gynghorwyr. Clerc i ddiweddarau'r Gofrestr Datganiad gyda'i fanylion yng nghyfarfod mis Mawrth

5477/25 – Cllr Dafydd Morgan attended Governors Meeting at Ysgol Llangadog, where it was noted that there was current issues regarding the roof (missing slates) and if CCC would be able to replace. County Cllr Andrew Davies to follow this up / Mynychodd y Cyng. Dafydd Morgan Gyfarfod Llywodraethwyr Ysgol Llangadog, lle nodwyd bod materion cyfredol ynglŷn â'r to (llechi coll) ac a fyddai CSC yn gallu gosod rhai newydd. Cyng Sir Andrew Davies i ddilyn hyn i fyny

5478/25 – Clerk requested the expenditure limit allowed for purchased without prior approval. Cllrs agreed the sum was to be £250 per month. Clerk to insert into Financial Regulations / Gofynnodd y Clerc am y terfyn gwariant y caniateir ei brynu

heb ganiatâd ymlaen llaw. Cytunodd y Cynghorwyr mai'r swm fyddai £250 y mis. Clerc i fewnosod yn y Rheoliadau Ariannol.

5479/25 –Precept 2025/2026 – Clerk informed that an email had been received from CCC in regards to Precept Form not being received. Confirmed that the form was sent on 8th January 2025 and CCC apologised as form could not be found and to resend. CCC confirmed receipt of for / Praesept 2025/2026 – Clerc wedi hysbysu bod e-bost wedi dod i law oddi wrth CSC yn dweud nad oedd Ffurflen Archebiant wedi ei derbyn. Cadarnhawyd bod y ffurflen wedi'i hanfon ar 8 Ionawr 2025 ac ymddiheurodd CSC gan nad oedd modd dod o hyd i'r ffurflen a'i hail-anfon. Cadarnhaodd CSC dderbyn y ffurflen.

5480/25 – Current Ongoing Issues / Materion Parhaus Cyfredol

- a. Footpath / Vicarage Road & Walters Road - Issue still ongoing / Llwybr Troed / Vicarage Road a Walters Road - Mae'r mater yn parhau.
- b. Faulty Street Light (Ivorite Cottage) – Cllr Wyn Jones informed that a meeting with National Grid is expected within the next week to discuss and get issue resolved. County Cllr Andrew Davies requested that he be notified of the site meeting as he would like to attend. Cllr Wyn Jones to contact Clerk when date is confirmed / Golau Stryd Diffygiol (Ivorite Cottage) – Hysbysodd y Cyng Wyn Jones ei fod disgwyl cyfarfod gyda'r Grid Cenedlaethol o fewn yr wythnos nesaf i drafod a datrys y mater. Gofynnodd y Cyngorydd Sir Andrew Davies iddo gael ei hysbysu o'r cyfarfod safle gan ei fod am fynychu'r cyfarfod. Cyng Wyn Jones i gysylltu â'r Clerc pan fydd y dyddiad yn cael ei gadarnhau.
- c. Red Lion Definitive Map – No further updates / Map Diffiniol Red Lion – Dim diweddariadau pellach
- d. Pumptrack – Clerk to investigate further costs involved in the building of the Pump Track / – Clerc i ymchwilio i gostau pellach sy'n gysylltiedig ag adeiladu'r Trac Pwmpio.
- e. Cattle Grid – Nantfforchog, Gwynfe – Cllr Alan Price confirmed no work had been completed to resolve the issue with the cattle grid. County Cllr Andrew Davies to follow this up / Grid Gwartheg – Nantfforchog, Gwynfe – Cadarnhaodd y Cyng Alan Price nad oedd unrhyw waith wedi ei gwblhau i ddatrys y mater gyda'r grid gwartheg. Cyng Sir Andrew Davies i ddilyn hyn i fyny.
- f. Drains – Cllr Alan Price and Cllr Hugh Davies reported that the drainage issues had not been resolved. County Cllr Andrew Davies confirmed that he had received an email from CCC that stated that the issue had been resolved and no further action required. Cllr Alan Price to forward video evidence that the drains have not been re-situated and that the flooding is getting progressively worse. County Cllr Andrew Davies to follow this up with CCC / dd. Draeniau – Adroddodd y Cyng Alan Price a'r Cyng Hugh Davies nad oedd y materion draenio wedi'u datrys. Cadarnhaodd y

Cynghorydd Sir Andrew Davies ei fod wedi derbyn e-bost oddi wrth CSC yn nodi bod y mater wedi'i ddatrys ac nad oedd angen unrhyw gamau pellach. Y Cyng Alan Price i anfon tystiolaeth fideo nad yw'r draeniau wedi'u hail-leoli a bod y llifogydd yn gwaethygu'n gynyddol. Cyng Sir Andrew Davies i ddilyn hyn i fyny gyda CSC.

- g. Speeding Issues (Ysgol Llangadog) – County Cllr Andrew Davies informed that this is still ongoing and that Mrs Anne Davies M.P. was also involved in trying to get this issue resolved. Further discussions about matrix signage to be purchased and placed outside the school area. Clerk to get more information on signage / g. Materion Goryrru (Ysgol Llangadog) – Dywedodd y Cynghorydd Sir Andrew Davies fod hyn yn dal i fynd rhagddo a bod Mrs Anne Davies A.S. hefyd yn ymwneud â cheisio datrys y mater hwn. Trafodaethau pellach am arwyddion matrices i'w prynu a'u gosod y tu allan i ardal yr ysgol. Clerc i gael mwy o wybodaeth am arwyddion.
- h. Cllr Dafydd Morgan discussed further the issue of livestock on Carreg Sawdde Common, still being attacked by loose dogs on the land. Clerk to investigate if any support can be given to try and monitor / stop this becoming a regular occurrence / Trafododd y Cyng. Dafydd Morgan y mater o dda byw ar Gomin Carreg Sawdde, sy'n dal i gael eu hymosod gan gŵn rhydd ar y tir. Clerc i ymchwilio a ellir rhoi unrhyw gefnogaeth i geisio monitro / atal hyn rhag dod yn ddigwyddiad rheolaidd.

- **Llangadog RFC** – Clerk informed that Paul Phillips had contacted to state that the new defib pads shelf life was only 1 year which is far less than expected. Clerk confirmed that on checking with Defib Store, the wrong product code was given by RFC / Clerc wedi hysbysu bod Paul Phillips wedi cysylltu i ddatgan mai dim ond 1 flwyddyn oedd oes silff y padiau defib

newydd sy'n llawer llai na'r disgwyl. Cadarnhaodd y Clerc wrth wirio gyda Defib Store, bod y RFC wedi rhoi'r cod cynnyrch anghywir.

- **Lawn Cemetery / Lawn y Fynwent** – no issues / dim materion
- **Llangadog Playground / Maes Chwarae** – Cllr Dafydd Morgan agreed to check report compiled by the Late Cllr John Hampson of equipment that needs replacing or the purchase of new. Clerk to give report to Cllr Dafydd Morgan to proceed before Summer / Cytunodd y Cyng. Dafydd Morgan i wirio'r adroddiad a luniwyd gan y Diweddar Gyngh. John Hampson o offer sydd angen eu newid neu brynu offer newydd. Clerc i roi adroddiad i'r Cyng Dafydd Morgan i symud ymlaen cyn yr Haf.
- **Village Green / Lawnt y Pentref** – Clerk informed that Solicitor has sent all relevant paperwork and application to HM Land Registry to register LCC as owners of the Village Green. Confirmation received from HM Land Registry that paperwork received but there is a backlog and registration could take longer to process / Clerc wedi hysbysu bod y Cyfreithiwr wedi anfon yr holl waith papur perthnasol a chais i Gofrestrfa Tir EM i gofrestru LCC fel perchnogion y Maes Pentref. Cafwyd cadarnhad gan Gofrestrfa Tir EM bod gwaith papur wedi'i dderbyn ond mae ôl-groniad a gallai gymryd mwy o amser i brosesu cofrestriad.
