5491/25 – Accounts 2024/2025 – Clerk informed that all payments are to be made by 31st March 2025 as the yearly accounts will need to be completed as from April 2025 / Cyfrifon 2024/2025 – Dywedodd y Clerc y bydd angen cwblhau pob taliad erbyn 31 Mawrth 2025 fel y gall y cyfrifon blynyddol ei cwblhau o Ebrill 2025.

5492/25 – Current Ongoing Issues / Materion Parhaus Cyfredol

- a. Footpath / Vicarage Road & Walters Road - Issue still ongoing / Llwybr Troed / Vicarage Road a Walters Road - Mae'r mater yn parhau.
- b. Faulty Street Light (Ivorite Cottage) – Cllr Wyn Jones to organise meeting with Western Power / – Cyng Wyn Jones i drefnu cyfarfod gyda Western Power.

- c. Red Lion Definitive Map – Mr Jason Lawday CCC dealing with DMMO Application. Awaiting further updates / Mr Jason Lawday CSC yn delio â chais DMMO. Aros am ddiweddariadau pellach.
- d. Pumptrack – Clerk received cost involved in building the Llandeilo Pump Track. The full cost was in the region of £102,000. Grants from Sports Wales and Welsh Government were awarded in the region of £37,000 towards the project. Cllrs agreed not to move forward with this, due to the costs / Clerc wedi derbyn y gost o adeiladu Trac Pwmpio Llandeilo. Roedd y gost lawn tua £102,000. Dyfarnwyd grantiau o tua £37,000 gan Chwaraeon Cymru a Llywodraeth Cymru tuag at y prosiect. Cytunodd y Cynghorwyr i beidio â symud ymlaen gyda hyn, oherwydd y costau.
- e. Cattle Grid – Nantfforchog, Gwynfe – Cllr Alan Price confirmed that the work had not been completed. Cllr Alan Price confirmed that the grid requires clearing and replaced with a grid in longer length. County Cllr Andrew Davies to follow this up / Cadarnhaodd y Cyng Alan Price nad oedd unrhyw waith wedi'i gwblhau. Cadarnhaodd y Cyng Alan Price fod angen clirio'r grid a gosod grid hirach yn ei le. Y Cyng Sir Andrew Davies i ddilyn hyn i fyny.
- f. Drains – Cllr Alan Price and Cllr Hugh Davies reported that the drainage issues had still not been resolved. County Cllr Andrew Davies to follow this up / Adroddodd y Cyng Alan Price a'r Cyng Hugh Davies nad oedd y materion draenio wedi'u datrys eto. Cyng Sir Andrew Davies i ddilyn hyn i fyny.
