5515/25 – Previous meeting minutes dated 1st April 2025 approved by Cllr Dafydd Morgan and seconded by Cllr Alan Price / Cymeradwywyd cofnodion y cyfarfod blaenorol dyddiedig 1 Ebrill 2025 gan y Cyng Dafydd Morgan ac eiliwyd gan y Cyn Alan Price.

5516/25 – Carmarthenshire YFC Annual Rally – Cllr Aaron Hughes and Cllr Jennifer Hughes will be attending. Clerk to give names for entry on the day / Rali Flynyddol CFfl Sir Gâr – Cyng Aaron Hughes a Cyng Jennifer Hughes yn mynychu. Clerc i roi enwau ar gyfer mynediad ar y diwrnod.

5517/25 – Bursary Scheme (Wales) – Clerk requested for approval to complete the FILCA course with SLCC and that there was a Bursary Scheme that could be applied for. All Cllrs approved / Cynllun Bwrsariaeth (Cymru) – Gofynnodd y Clerc am gymmeradwyaeth i gwblhau cwrs FILCA gyda SLCC a bod Cynllun Bwrsariaeth y gellid gwneud cais amdano. 5518/25 – Community Shop / The Limes – Cllrs discussed further the email request received asking for our support towards the community running the shop as a community venture. County Cllr Andrew Davies informed he was also approached for support. Issue was discussed further and it was agreed that as a Community Council, we can engage with our local community / residents to understand their concerns, but unfortunately, it is not within our remit to involve ourselves in any matters for which the Community Council is not responsible for. Clerk to reply to Martin Price / Siop Gymunedol / The Limes - Bu'r Cynghorwyr yn trafod ymhellach y cais e-bost a dderbyniwyd yn gofyn am ein cefnogaeth i'r gymuned redeg y siop fel menter

gymunedol. Dywedodd y Cynghorydd Sir Andrew Davies ei fod wedi gofyn iddo hefyd am gefnogaeth. Trafodwyd y mater ymhellach a chytunwyd y gallwn fel Cyngor Cymuned ymgysylltu â'n cymuned / trigolion lleol i ddeall eu pryderon, ond yn anffodus, nid yw o fewn ein cylch gorchwyl i gynnwys ein hunain mewn unrhyw faterion nad yw'r Cyngor Cymuned yn gyfrifol amdanynt. 5519/25 – Missing Council Bin – County Cllr Andrew Davies has raised issue with DSU in regards to the removal of the bin outside the Black Lion (Llangadog) and also Bethlehem. Awaiting response / Bin Cyngor ar Goll – Mae'r Cynghorydd Sir Andrew Davies wedi codi'r mater gyda'r DSU mewn perthynas â chael gwared ar y bin y tu allan i'r Llew Du (Llangadog) a hefyd Bethlehem. Aros am ymateb

5520/25 – Unoccupied Council Properties (Rhyd y Fro) – Cllr Dafydd Morgan reported that there are a few council properties in the village currently unoccupied by the tenants, as they are living elsewhere and there could be issues if the tenants are claiming any form of benefit on the properties. Also, there are families within the village on the waiting list for council properties that could benefit from these empty homes. County Cllr Andrew Davies to speak to CCC and report back to LCC / Tai Cyngor Gwag (Rhyd y Fro) – Adroddodd y Cyng. 5521/25 – Current Ongoing Issues / Materion Parhaus Cyfredol

- a. Footpath / Vicarage Road & Walters Road - Issue still ongoing / Llwybr Troed / Vicarage Road a Walters Road - Mae'r mater yn parhau.
- b. Faulty Street Light (Ivorite Cottage) – Cllr Wyn Jones to contact National Grid to set up site visit / Cyng Wyn Jones i gysylltu â'r Grid Cenedlaethol i drefnu ymweliad safle.
- c. Red Lion Definitive Map – No further updates / Dim diweddariadau pellach.
- d. Cattle Grid – Nantfforchog, Gwynfe – County Cllr Andrew Davies informed that the new grid has already been fabricated to the old dimensions and could not be amended. Cllr Alan Price and Cllr Hugh Davies agreed for the grid to be installed and if there were still issues, to report back to County Cllr Andrew Davies / Dywedodd y Cynghorydd Sir Andrew Davies fod y grid newydd eisoes wedi'i wneud i'r hen ddimensiynau ac na ellid ei ddiwygio. Cytunodd y Cyng Alan Price a'r Cyng Hugh Davies i'r grid gael ei osod ac os oedd problemau o hyd, i adrodd yn ôl i'r Cynghorydd Sir Andrew Davies
- e. Drains – Cllr Alan Price and Cllr Hugh Davies reported that the drainage issues had still not been resolved. The problem needs to be monitored during a period of wet weather to be able to try and resolve the matter. County Cllr Andrew Davies to follow this up. / e.
