5458/25– Apologies from Cllr Dafydd Morgan, Cllr Jennifer Hughes and County Cllr Andrew Davies / Ymddiheuriadau gan y Cyng. Dafydd Morgan, y Cyng Jennifer Hughes a'r Cyng Sir Andrew Davies

5459/25 – No Disclosures or Declaration of Interests noted / Dim Datgeliadau neu Ddatganiad o Ddiddordeb wedi eu nodi.

5460/25 – Previous meeting minutes dated 3rd December 2024 approved by Cllr Wyn Jones and seconded by Cllr Aaron Hughes / Cymeradwywyd cofnodion y cyfarfod blaenorol dyddiedig 3 Rhagfyr 2024 gan y Cynghorydd Wyn Jones ac eiliwyd gan y Cyng Aaron Hughes.

5461/25 – Appointment of Vice Chair. Cllr Aaron Hughes voted in as temporary Vice Chair, until the AGM which is held in May 2025 / Penodi Is-Gadeirydd. Pleidleisiodd y Cynghorydd Aaron Hughes i mewn fel Is-Gadeirydd dros dro, tan y Cyfarfod Cyffredinol Blynnyddol a gynhelir ym mis Mai 2025.

5462/25 – To receive Councillors reports on events and meetings attended on behalf of the Council – no events or meetings held / Derbyn adroddiadau Cynghorwyr ar ddigwyddiadau a chyfarfodydd a fynychwyd ar ran y Cyngor – ni chynhaliwyd unrhyw ddigwyddiadau na chyfarfodydd.

5463/25 – Digital Guidance (Domain Naming) – Orchardweb looked into pricing for domain name with GOV.Wales and cyf.cymru, the cost is £120 plus VAT every two years. Cllrs agreed that they are happy with our current website and no changes will be made / Canllawiau Digidol (Enwi Parth) – Edrychodd Orchardweb ar brisio enw parth gyda GOV.Wales a cyf.cymru, y gost yw £120 ynghyd â TAW bob dwy flynedd. Cytunodd y Cynghorwyr eu bod yn hapus gyda'n gwefan bresennol ac ni fydd unrhyw newidiadau yn cael eu gwneud.

5464/25 –Precept 2025/2026 – Cllrs discussed budgetary requirements for the year and agreed for the Precept for 2025/2026 to be increased from £23,000 to £25,000, due to extra expenditure to cover solicitors fees and upgrading Llangadog Playground / Praesept 2025/2026 – Trafododd y Cynghorwyr ofynion cyllidebol am y flwyddyn a

chytunwyd i godi'r Praesept ar gyfer 2025/2026 o £23,000 i £25,000, oherwydd gwariant ychwanegol i dalu ffioedd cyfreithwyr ac uwchraddio Cae Chwarae Llangadog.

5465/25 – Current Ongoing Issues / Materion Parhaus Cyfredol

- a. Footpath / Vicarage Road & Walters Road. Email received from resident who has requested, again, that the footpath requires urgent attention. Clerk emailed PROW to request more information on the sensors that had been installed. Welsh Government funding was utilised to install the sensors. Cllr Haulwen Booth reminded the meeting that an email had been received from CCC about the delays (Oct 2024) / Llwybr Troed / Vicarage Road a Heol Gwallter. E-bost wedi ei dderbyn gan breswlydd sydd wedi gofyn, unwaith eto, bod angen sylw brys ar y llwybr troed. Anfonodd y Clerc e-bost at HTC i ofyn am fwy o wybodaeth am y synwryddion oedd wedi eu gosod. Defnyddiwyd cyllid Llywodraeth Cymru i osod y synwryddion. Atgoffodd y Cyng Haulwen Booth y cyfarfod fod e-bost wedi dod i law oddi wrth CSC am yr oedi (Hydref 2024).
- b. Faulty Street Light (Ivorite Cottage) – Cllr Wyn Jones still waiting to set up a site meeting with Western Power / b. Golau Stryd Diffygiol (Ivorite Cottage) – Cyng Wyn Jones yn dal i aros i drefnu cyfarfod safle gyda Western Power.
- c. Red Lion Definitive Map – No further updates / Map Diffiniol Red Lion – Dim diweddariadau pellach
- d. Pumptrack – Clerk to organise meeting with Carl Daniels and Rhian Phillips to discuss further / Clerc i drefnu cyfarfod gyda Carl Daniels a Rhian Phillips i drafod ymhellach.
- e. Cattle Grid – Nantfforchog, Gwynfe – no work has been completed. Cllr Alan Price and Cllr Hugh Davies have requested that this issue reported again as the cattle grid needs replacing urgently. Weather conditions are causing debris to flow into and fill the grid, allowing livestock to cross over. County Cllr Andrew Davies to report issue again to CCC / – dim gwaith wedi ei gwblhau. Mae'r Cyng Alan Price a'r Cyng Hugh Davies wedi gofyn i'r mater hwn gael ei adrodd eto gan fod angen newid y grid gwartheg ar frys. Mae'r tywydd yn achosi i falurion lifo i mewn i'r grid a'i lenwi, gan alluogi da byw i groesi drosodd. Cyng Sir Andrew Davies i adrodd y mater eto i CSC
- f. Speeding Issues (Ysgol Llangadog) – email received from County Cllr Andrew Davies to give an update on results of the traffic survey completed outside the school, which was not conducted at the correct time of the year. The survey would not reflect the true amount of motorcycle traffic that the village incurs during the summer months. County Cllr Andrew Davies requested support from the Cllrs to reinstate the traffic hump that was removed in advance of the Cycle Race a few years ago. Cllrs agreed for the Clerk to email CCC in regards to this / dd. Materion Goryrru (Ysgol Llangadog) – derbyniwyd e-bost gan y Cyngorydd Sir Andrew Davies yn rhoi diweddariad ar ganlyniadau'r arolwg traffig a gwblhawyd y tu allan i'r

ysgol, na chafodd ei gynnal ar yr adeg gywir o'r flwyddyn. Ni fyddai'r arolwg yn adlewyrchu gwir faint o draffig beiciau modur y mae'r pentref yn dioddef yn ystod misoedd yr haf. Gofynnodd y Cynghorydd Sir Andrew Davies am gefnogaeth gan y Cynghorwyr i adfer y twmpath traffig a dynnwyd cyn y Ras Feiciau ychydig flynyddoedd yn ôl. Cytunodd y Cynghorwyr i'r Clerc e-bostio CSC ynglŷn â hyn.

5466/25 – Email of thanks received from Gwynfe Hall for the donation given towards their Xmas lights / Ebost o ddiolch wedi ei dderbyn oddi wrth Neuadd Gwynfe am y rhodd tuag at eu goleuadau Nadolig.

5471/25 – Items requiring a decision relating / Eitemau y mae angen penderfyniad yn eu cylch

- **Llangadog RFC** – Cllr Alan Price to ask Paul Phillips for quote to replace defib pads as agreed so that Clerk can purchase / Cyng Alan Price i ofyn i Paul Phillips am bris i newid padiau defib fel y cytunwyd fel y gall y Clerc brynu.
- **Lawn Cemetery / Lawn y Fynwent** – no issues / dim materion
- **Llangadog Playground / Maes Chwarae** – Cllr Wyn Jones agreed to install signs in playground. Further discussions required with Cllr Dafydd Morgan to move forward with updating the playground / Cytunodd y Cyng Wyn Jones i osod arwyddion yn y maes chwarae. Angen trafodaethau pellach gyda'r Cyng Dafydd Morgan i symud ymlaen gyda diweddaru'r maes chwarae.
- **Village Green / Lawnt y Pentref** – Cllrs requested the contact be made with Solicitors for an update on the changes to land registry for the Village Green. Clerk to make contact with solicitors for update. Cyng yn dymuno cael diweddariad ar y newidiadau i'r gofrestr tir ar gyfer Lawnt y Pentref. Clerc i gysylltu â'r cyfreithiwr am ddiweddariad.
- **Carreg Sawdde Common** – Clerk to make contact with solicitor for update / Clerc i gysylltu â'r cyfreithiwr am ddiweddariad
- **Roads & Hedges / Ffyrdd a Gwrychoed** – Cllr Haulwen Booth reported that since the storms the roads / drains have become even more unsuitable

within the areas, and there is a lot that needs to be cleared by CCC. Cllr Alan Price and Cllr Hugh Davies reported that the drains installed in between their properties are in the wrong place and that they need to be moved. Request for County Cllr Andrew Davies to report this and request a site visit be made with both Cllrs, to ensure the drains are placed in the correct place. Clerk to email County Cllr Andrew Davies / Adroddodd y Cyng Haulwen Booth ers y stormydd bod y ffyrdd / draeniau wedi dod yn fwy anaddas fyth o fewn yr ardaloedd, ac mae llawer i'w glirio gan CSC. Dywedodd y Cyng Alan Price a'r Cyng Hugh Davies fod y draeniau sydd wedi'u gosod rhwng eu heiddo yn y lle anghywir a bod angen eu symud. Cais i'r Cynghorydd Sir Andrew Davies adrodd hyn a gofyn am ymweliad safle gyda'r ddau Gynghorydd, i sicrhau bod y draeniau'n cael eu gosod yn y lle cywir. Clerc i anfon e-bost at y Cynghorydd Sir Andrew Davies.

- **Public Lighting / Goleuadau Cyhoeddus** – Cllr Jennifer Hughes reported, via email, that two lights are currently out on the Common, one by the bus shelter and the other right hand side as approaching the village. Clerk to get numbers from poles to report to CCC / Adroddodd y Cyng Jennifer Hughes, trwy e-bost, bod dau olau wedi eu diffodd ar y Comin ar hyn o bryd, un wrth ymyl y lloches bws a'r llall ar yr ochr dde wrth nesáu at y pentref. Clerc i gael rhifau o'r polion i adrodd i CSC.
