5640/26 – Welsh Water Correspondence – All Cllrs made aware of the work planned for the areas of Llangadog/Manordeilo/Cwmifor, due to begin the end of February 2026 / Gohebiaeth Dŵr Cymru – Rhoddwyd gwybod i bob Cynghorydd am y gwaith a gynlluniwyd ar gyfer ardaloedd Llangadog/Manordeilo/Cwmifor, a ddisgwylir iddo ddechrau ddiwedd mis Chwefror 2026.

5641/26 – Llandovery Pylon Steering Group – Email received from LPSG with update on their attendance to the High Court, where the judge ruled in their favour and granted permission for the Judicial Review to proceed into the process and behaviour adopted by Green GEN. They have agreed to not attempt to access any land or carry out further surveys until the next meeting. a. Llangadog RFC / Clwb Rygbi Llangadog – no further updates on installation of gate to school..

- Cllr Alan Price informed that Llangadog RFC are due to play on 21st March in the cup game semi final and if they win, they will be through to the final to be held at the Millenium Stadium. He suggested that as this would be a great achievement for Llangadog RFC and the area, would LCC be willing to support the event by donating towards the cost of coaches to take the local school children to watch the match. This could also maybe prompt further generations to play the game. Cllrs discussed and agreed, plus maybe the purchase of an item from Llangadog RFC club website (it bobble hat) for each child. Awgrymodd, gan y byddai hyn yn gamp fawr i Glwb Rygbi Llangadog a'r ardal, a fyddai CLG yn fodlon cefnogi'r digwyddiad trwy gyfrannu tuag at gost bysiau i fynd â phlant yr ysgol leol i wyllo'r gêm. Gallai hyn hefyd annog cenedlaethau pellach i chwarae'r gêm. Trafododd a chytunodd y Cynghorwyr, ynghyd ag efallai prynu eitem o wefan clwb Clwb Rygbi Llangadog (het bobble) i bob plentyn. I'w drafod ymhellach ar ôl 21 Mawrth.

b. Lawn Cemetery / Lawn y Fynwent - Cllr Dafydd Morgan suggested that as a new project for 2026, the Lawn Cemetery to be updated. Tenders could be put out for any interested parties to take on the work. Cllrs to discuss further at the Finance Meeting held in March / Awgrymodd y Cynghorydd Dafydd Morgan, fel prosiect newydd ar gyfer 2026, y dylid diweddarau Mynwent y Lawnt. - d. Bethlehem - Garn Goch – Hedge bank wall collapsed onto road. Beyond Bailey farm towards the village – a large pothole.

- e. Gwynfe – beyond Bailey Home Farm – potholes as well as from the village towards the school by Bryncoch. Brynclydach square – blocked drain and a large pothole.
- f. Llangadod - Potholes coming into village (Bran Bridge)
- g. Road Signs – CCC agreed to replace the Maes y Wern sign outside the 4 houses in Gwynfe. Not completed.
- h. Pothole – outside Ddyfadfa Isaf, Gwynfe (Cllr Alan Price Farm)
- i. Road up towards Cennen Tower

- f. Public Lighting / Goleuadau Cyhoeddus** - the faulty street lights outside the Wynstay belong to CCC. They will be starting excavation work to resolve the issue at the end March as the cables are currently underground / - mae'r goleuadau stryd diffygiol y tu allan i'r Wynstay yn eiddo i CSC.
